H. Hunt declares the meeting open at 11:10am.

Welcome of Accord members and individual introductions.

C. Donovan reads the minutes from the previous meeting. C. Murray moves to accept the minutes as read, seconded by J. Turnbull.

New Business: There being no new business the chairman moves on.

Correspondence: There being no correspondence the chairman moves on.

General Business:

No Treasurer's Report is presented as there was no income for the period and few expenses aside from the printing of the raffle tickets for the *Go 0.000 and be a Hero* campaign.

Det. Insp. B. Bernie presents the Green Valley LAC report (see attached). There was one incident of note being a robbery at Green Valley Hotel. Youths waited in the toilets until after close. Security checks of toilets prior to close are recommended. There has also been trouble in Miller with minors obtaining alcohol.

Const. A. Lynes presents the Liverpool LAC report (see attached). Sen. Const. P. Arnold is stepping down from the LCLA. Const. A. Lynes will replace him in the interim while a permanent replacement is sought. With respect to recent instances of media recording footage of police operations on licensed premises, the licensee is within their rights to turn away media. Directly approaching the media or senior police officer on sight to make your wishes clear is recommended. Please contact Sgt. J. Gibson with any questions.

R. Palermo highlights some new posters that are available from Liverpool City Council for the RMS Plan B campaign. K. Rahmun provides an update on the camera installations in taxi

ranks in Liverpool. There will be two cameras installed at each of the Macquarie Street and Railway Street taxi ranks by the end of December.

H. Hunt thanks Accord members for attending on behalf of the Executive Committee, and explains the purpose of the Accord: to support communication between Police, Council and licensees; to encourage responsible practices in the supply of alcohol; and to make the public aware of *their* responsibilities in the supply and consumption of alcohol.

H. Hunt asks for an expression of interest in receiving information about other local committees in future meetings, such as the Liverpool Chamber of Commerce, Liverpool Council Economic Development Committee, the Badgerys Creek Airport Alliance and the Western Sydney Parklands Plan to 2020. Accord members broadly expressed support for the suggestion.

J. Henry highlights correspondence between himself and the Executive Committee regarding the need to give enough notice for meetings, and the requirement for the Accord to hold an Annual General Meeting during the calendar year with four weeks' notice to members, for which the opportunity has now lapsed.

H. Hunt suggests the AGM will be held at the next meeting on 25th February 2014 for which invitations to nominate will be distributed to members. He indicates that it will be possible to apply for an extension on the deadline allowing the AGM to be held next year.

C. Murray suggests that moving forward the last meeting of the year must be the AGM with minutes and financial information sent out a minimum of six weeks prior. The motion is carried.

There being no further business the chairman declares the meeting closed at 11:45am.

2. Police consider an incident to have occurred *on licensed premises* if it:

- (i) *Occurs on the premises itself,*
- (ii) *Occurs in the immediate vicinity of the premises (eg footpath or car park) where there is evidence of direct involvement with the premises, or*
- (iii) *Can be directly attributable to the premises.*

3. **If a licensee permits intoxication, violent, quarrelsome, or disorderly conduct on licensed premises,** the licensee is liable to be issued with \$1100.00 penalty notice, or a Court Attendance Notice for any breaches.

Re: Sect 73 Liquor Act (NSW) 2007

❖ Pursuant to Sect 149 Liquor Act (NSW) 2007, Licensees and Managers are liable for act of employees.

4. **House Keeping.**

Venues are responsible to carryout regular checks/internal audits of all records, registers, and mandatory liquor and gaming signage at your respective licensed premises.

❖ *Self audit checklists for licensed premises are on the OLGR website that can be downloaded.*

5. **Minors.**

Minors have been detected in licensed premises or attempting to gain entry to licensed premises with fake identification, or using other persons ID. Management, staff and security to be vigilant with ID checks.

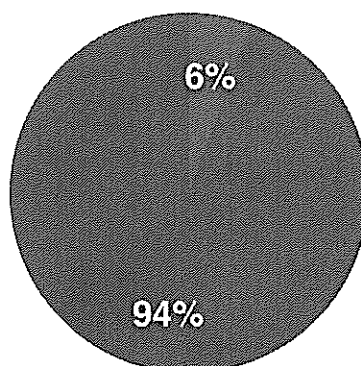

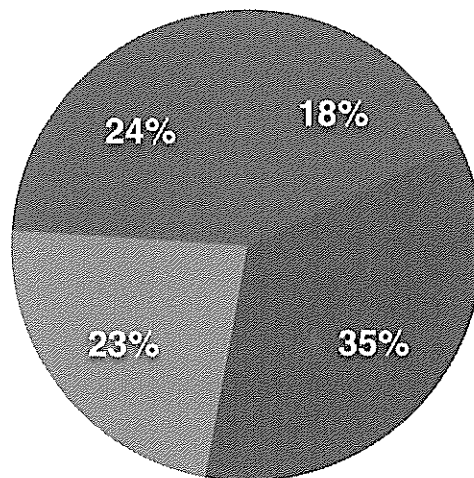

- other / not known

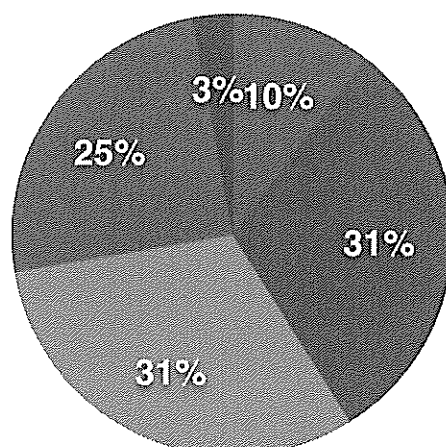


Level of Intoxication Report

The police deal with 5 different levels of intoxication which is opinion formed by the officer based on their observations of the person and other indicators. Whilst the police use this information to capture data which can assist in assessing persons in custody it is not the level required under Legislation such the Liquor Act or Law Enforcement Powers and Responsibilities Act.

This level is only "Noticeably Affected" and the change in behaviour of the person so affected can be reasonably presumed is as the result of consuming alcohol or ANY drug. (As in the case of LEpra).

The Go Zero campaign was well received by the public and the winners are being notified, it's a long process than initially expected but I think it was a good concept and thank you to those who assisted or participated.

We are still working with council about taxi ranks and this will be on going for the next 12 months. But if you have any ideas about how to improve our area of facilities please let me know.

This includes simple things such as rubbish removal or if you have an idea to bring in people to the area then let us know that as well.

Council is working hard to bring a different vibe to the CBD and any idea is great. The installation of CCTV and projects including free WiFi are all great to promote our area as a safe one.

So put your heads together and let's bring something amazing.

Also on the 10th of December is the next meeting of the Liverpool Community Drug and Alcohol Action Team. It's a group which needs your input to help fight alcohol abuse in youths, in the home, on the streets and on the roads. The input you can provide as professionals can be invaluable. Recently there was a current affair program following police on an operation. If you don't want these crews filming as far as I have been told let them know when they walk in. You have that right. Sometimes the time between filming and going to air is tiny and police do not have editing approval. 90% of premises attended informed the program when entering they did not wish their premises filmed and the program staff left immediately as far as I am aware. I was not involved in the operation myself and have got this information retrospectively. I am happy to hear your concerns and pass on where possible. So let your staff know where you stand on these issues and it may stop any future issues in its tracks.

Lastly if I have been out of contact I apologise I have been involved in some projects lately which are on a larger scale and have taken me away. But please give me a call with any issues or send me a email anytime and I will get back to you ASAP.
