

Minutes of the Liverpool City Liquor Accord General Meeting Held at Liverpool Catholic Club Tuesday 28th August 2018

The chairman declared the meeting open at 11am. Members present conducted self introductions. The minutes from the previous meeting held 29th May 2018 were read. It was moved that the minutes be accepted as read and there being no objection the motion was carried.

General Business:

Kee Sisouvath presented the Liverpool police report. Numbers for alcohol related incidents are still good, however a drug dog operation in July revealed a number of detections on premises. Assaults on premises resulting from alcohol have increased and licensees need to be mindful of RSA. Cut off affected patrons and remove them from premises early to avoid problems. Harry Hunt asked if there was a strong correlation between alcohol consumption and domestic violence, and if this could be covered in the next police report.

Harry Hunt opened the floor to any issues facing members.

Marta Liversedge noted that traffic works at Rossmore Cellars is likely to cut business by 70% with road barricades restricting entry from west bound traffic.

John Turnbull encouraged accord members to take advantage of the opportunity to meet and build a working relationship with licensing police, and thanked police for their contribution to the accord and the business. He outlined the new development underway at Liverpool Catholic Club which includes four new food outlets, a large indoor playground and a 300-seat movie theatre.

Peter Suggett noted difficulty in finding quality staff and that in recent times the majority of candidates have extremely limited availability and don't want to work nights or weekends.
